Nearly 11500 American and 290000 South Korean troops will be participating in a month-long a series of field training exercises to be held under 'Foal Eagle drill'. Earlier, the drill was to be held in February 2018. However, it was delayed in order to avoid a clash with Winter Olympic Games 2018 in Pyeongchang, South Korea. This edition of 'Foal Eagle drill' will be a low-key event, featuring fewer strategic weapons, as North Korea has proposed to hold summits with the South Korea and US, which has in turn eased the tension and diplomatic rhetoric on Korean peninsula

Answer - (c) India Explanation: As per information shared by Indian Cellular Association (ICA) with Telecom Minister Manoj Sinha and IT Minister Ravi Shankar Prasad, India is now the second largest mobile phone producer in the world after China. ICA's claim was based on data available from market research firm IHS, China's National Bureau of Statistics and Vietnam General Statistics Office. With 11 million units produced in 2017, India replaced Vietnam as the second largest producer of mobile phones in 2017. It is to be noted that annual production of mobile phones in India in 2014 was just 3 million units. On account of rise in domestic production, imports of the devices in India also reduced to less than half in 2017-18. Fast Track Task Force (FTTF), a body under Union Ministry of Electronics and IT, has set target to achieve around 500 million mobile phone production in India by 2019.

Answer - (b) West Bengal Explanation: West Bengal State Government has rolled out Chief Minister Mamata Banerjee's dream project "Rupashree" scheme aimed at providing marriage assistance to girls coming from economically weaker families. This scheme was announced by West Bengal Finance Minister Amit Mitra while presenting the state budget for 2018-19. To avail financial assistance under this scheme, a woman has to fill the application form before her marriage and submit it to the Block Development Officer (BDO) or Municipality Office. Post submission of the form, amount of Rs 25000 will be credited to her bank account before her marriage. Only those women, whose annual family income is up to Rs (a) 5 lakh are eligible for this scheme. Besides, women must be a permanent resident of West Bengal and must have attained 18 years age at the time of their marriages. There is no minimum educational qualification to apply for this scheme. Budgetary allocation for this scheme is Rs 1500 crore and is expected to benefit around six lakh women every year.

StartupBlink is a global map and directory of startups, coworking spaces, accelerators, investors and reporters. Startupblink report includes a global ranking index which has been compiled by measuring startup ecosystem strength and activity in 125 countries and 900 cities. The rankings have been compiled in association with ANSYS Startup Program and are based on thousands of data points gathered since 2014, including data collected by StartupBlink's representatives in more than 70 chapters around the world. Entrepreneurs can refer the rankings to determine if a particular city has suitable business environment and resources needed to support their goals. India's 37th rank outlines that there is still much to be done in terms of ease of doing business, startup policies and easing tax compliance. Besides, Indian startup ecosystem is also yet to see major exits, which is considered as an important indicator of maturity of a startup ecosystem. In global ranking of cities, Bengaluru, New Delhi, and Mumbai are the top three Indian cities that have featured

in the list. United States (US) has topped the global ranking index of countries, followed by United Kingdom (UK) and Canada. Among Asian Countries, Singapore (at 10th spot) has attained the highest ranking. Four African nations that have featured in the list are South Africa (38th), followed by Kenya (53rd), Egypt (54th) and Nigeria (57th).

Answer - (c) Chennai Explanation: Japan International Cooperation Agency (JICA) and Indian Government have signed an agreement to provide a loan of 8,082 million Japanese Yen (Rs 500 crore) for installation of intelligent transport systems in Chennai. As per the agreement, the project is aimed to develop an efficient traffic system in Chennai Metropolitan area by installing Intelligent Transport Systems to reduce traffic congestion and increase economic growth. Once the project is completed, queues at main intersections in Chennai will be reduced. Official Development Assistance (ODA) is provided at an interest rate of 1.5 per cent for the project activities and 0.01 per cent for consulting service. The repayment period is 30 years. The Official Development Assistance loan agreement was signed by Ambassador of India to Japan, Sujan R Chinoy and JICA, Senior Vice-President, Junichi Yamada at the Iikura House of the Ministry of Foreign Affairs, Tokyo. Executing agency of the project is Chennai Smart City Ltd. The project will be executed on the existing road network in Chennai.

He is followed by Bill Gates at the second spot with a net worth of \$90.4 billion. The third position is

occupied by Warren Buffett with \$8.55 billion net worth. Jack Ma, Executive Chairman of Alibaba Group, is Asia's richest person with \$47.2 billion net worth. He is followed by Pony Ma, Tencent co-founder and CEO, with \$41.1 billion net worth. Srikrishnan, who was earlier with HDFC Bank and Yes Bank, has been appointed as MD and CEO of Jio Payments Bank. Payment Bank are special category banks, which have been approved by Reserve Bank of India (RBI) to promote financial inclusion. It undertakes restricted banking activities. Currently it is permitted to accept deposits up to Rs. 1 lakh and is not permitted to offer loans. In November 2016, Airtel Payment Bank became the first entity to commence operations as Payments Bank. Paytm Payments Bank and Fino Payments Bank commenced operations in 2017. India Post Payments Bank, which also got a license for a payment bank is yet to start its full-fledged operations in a formal way.

This joint venture will work on photovoltaic technology that is used in solar panels. Technology support will be provided by GCL and SoftBank will help in obtaining land and regulatory approvals. In 2015, SoftBank said that it would invest up to \$20 billion along with Foxconn Technology and Bharti Enterprises in solar projects in India with an aim to attain a capacity up to 20 gigawatts (GW). The joint venture between SoftBank and GCL will have a capacity of 4GW. It will be implemented in two 2GW phases. SoftBank will own 60 percent of the joint venture's shares and GCL will own 40 percent. The project will be funded by SoftBank's Vision Fund.

It aims at making flying a reality for common people residing in Tier-II and Tier-III towns by providing air connectivity to currently underserved and unserved airports. India has surpassed Japan and has become the second largest producer of crude steel in the world. Nikunj Turakhia, president of SUFI said that, India's growth in steel production is due to the policies introduced by the government. According to the World Steel Association, India produced 8.4 MT of crude steel in February 2018, which is 3.4% more than February 2017.

Julius Maada Bio ruled Sierra Leone as the military head in 1996, along with former foreign affairs minister Kamara. Julius Maada Bio took oath as the new President of Sierra Leone on 5th April 2018.

This scheme is for socio economic development of tribals living in forests, for whom, collecting Minor Forest Produce (MFP) is a major source of livelihood. The first "Van Dhan Vikas Kendra" in Bijapur District of Chhattisgarh will provide skill upgradation and capacity building training and will have primary processing and value addition facility. Initially, this Kendra will have processing facility for Tamarind brick making, Mahua flower storage facility and chironjee cleaning and packaging.

The improved cross-border payments service which is being referred to is the gpi (Global Payment Innovation) Tracker, which has been extended to cover all payment instructions sent across the SWIFT network. SWIFT's gpi tracker enables real-time payments tracking across correspondent banks and has a facility to track the payments instructions across the correspondent banks globally. It said that investment revival would continue, but at a modest rate. Also, ADB projected inflation to increase up to 4.6 % in FY2018 and 5 % percent in FY2019 supported by further strengthening of global commodity prices and domestic demand. It said that improved growth in advanced economies will help exports to improve in a healthy rate. Also, imports are expected to increase due to higher commodity prices and increase in domestic demand. The current account deficit would widen to 2.2 percent of GDP in FY2018 and 2.4 percent of GDP in FY2019. It also said that, current account deficit is expected to be financed by capital flows.

LRS scheme was introduced on February 4, 2004. At that time the limit was just USD 25000. However it was revised in a phased manner in line with prevailing macro and micro economic conditions and now stands at USD 250000 per financial year. Individuals can avail foreign exchange for this purposes within the limit of USD 250000 only, from Authorised Dealers/Banks. However, till now, Authorised Dealers/Banks permitted LRS transactions solely on the declaration made by the remitter and thus monitoring of adherence to the limit was confined to obtaining such a declaration without independent verification. Still Citizens from Pakistan, China and Afghanistan are banned from all PAP areas, including Nagaland, Mizoram and Manipur. According to a circular released on 30th December 2010 by the government, Manipur, Mizoram and Nagaland were excluded from the protected area regime initially for a period of one year from 1st January 2011, subject to certain conditions. According to the guidelines, a foreign national is not normally allowed to visit a protected or restricted area. He/She will be allowed only if the government is satisfied that there are extraordinary reasons to justify his or her visit. Every foreigner, except a citizen of Bhutan, who wishes to enter a protected or restricted area, should obtain a special permit from an authority having the power to issue such permits.
