All India Radio (AIR) and Doordarshan. He joined PIB in 2003. He succeeds Frank Noronha (superannuated on April 30, 2018) as the Director General of Press Information Bureau (PIB). In 1988, Sitanshu Ranjan Kar became the first Indian to win the prestigious Visnews Fellowship of London, under which, he travelled throughout Europe and North America to experience cutting-edge technologies being used in television news production by leading broadcasters.

With digital authentication, the farmers will no longer have to visit revenue offices or the Maha e-seva centres. They would simply be required to quote the gat (group) number or survey number to bank or a government department, through which respective agency can ensure the 7/12 receipt online. Maharashtra Chief Minister Devendra Fadnavis claimed that this initiative will enhance 'ease of doing business', would check irregularities and bring in transparency.

In addition to restructuring and renaming MsDP, CCEA has also approved its continuation during the remaining period of 14th Finance Commission at the cost of Rs. 3972 crore.

InSight aims to explore interior conditions on Mars, inform efforts to send human explorers to Mars, find out how rocky planets like Earth formed, etc. InSight is expected to settle on Mars on 26th November 2018.
