He became the **first Indian player** to be associated with the South African tournament.

i.Karthik will join his former Royal Challengers Bengaluru (RCB) and Delhi Daredevils teammate AB de Villiers as one of the league's ambassadors.

ii.Karthik has announced his retirement from all forms of cricket in June 2024.

**iii.**He played for India in 26 Tests, 94 One Day International (ODI), and 60 T20Is. He was also a part of the Indian team that won the 2007 T20 World Cup South Africa.

**iv.**He has signed to join **Paarl Royals** as an overseas player ahead of the 2025 season, becoming the first Indian player to feature in the SA20.

- Muhammad Yunus and his Grameen Bank won the Nobel Peace Prize for 2006 for their work to "create economic and social development from below"
- The appointment comes a day after Bangladesh Prime Minister(PM) **Sheikh Hasina resigned** and fled Bangladesh following a violent crackdown on a student-led uprising.
- Sheikh Hasina was the longest serving PM in Bangalseh history, until her resignation on 5
  August 2024. She served as 1st term as PM from 1996 to 2001 and again from January 2009 to
  August 2024.
