The **Securities and Exchange Board of India** (SEBI) has set up an **Ad-hoc Committee** to review the **ownership and economic structure** of **Clearing Corporations (CCs)** and to suggest measures to ensure that CCs function as resilient, independent, and neutral risk managers.

- The ad-hoc committee will be chaired by Usha Thorat, former Deputy Governor (2005 to 2010) of the Reserve Bank of India (RBI).
- The Ad-hoc committee will examine the feasibility and expand the list of eligible investors
  who are permitted to take shareholding in a clearing corporation and suggest categories of
  investors who can acquire shareholding in such corporations.
- A 2018 report by the Committee on Review of Regulations and Relevant Circulars related to Market Infrastructure Institutions (MIIs), led by R Gandhi (referred to as Gandhi Committee), stated that MII ownership should be diversified and widely owned.

- This also mark's India's first Foreign policy assignment under the historic 3rd consecutive term of Prime Minister (PM) Narendra Modi.
- This is the 1st foreign ministers meeting since the expansion of BRICS in 2023.

- Massachusetts Institute of Technology (MIT), Cambridge, the United States of America (USA) has topped the list globally for the 13th time (2012 and from 2014 to 2025).
- MIT is followed by Imperial College London, the United Kingdom (UK) at the 2nd position and The University of Oxford (UK) and Harvard University (USA) at 3rd and 4th position respectively.
- Delhi based Guru Gobind Singh Indraprastha University (GGSIPU), formerly known as Indraprastha University (IP university or IPU), has bagged the prestigious "Rising Star" award from the QS World Ranking.

- Informal employment has risen from 1.7 billion in 2005 to 2.0 billion in 2024, slowing progress towards Sustainable Development Goals (SDGs).
- Globally, only 45.6% of working-age women are employed in 2024, compared to 69.2% of men.

- Of the 181 million children, 65% of affected children live in 20 countries (including India), with high numbers in South Asia (around 64 million) and Sub-Saharan Africa (59 million).
- 9 out of 10 children in the Gaza Strip are consistently experiencing severe food poverty, surviving on 2 or fewer food groups per day.

The report evaluates the pipeline of antibacterial agents, including antibiotics, in clinical and preclinical development across the world.

i.According to the report, 84% of antibacterial Research and Development (R&D) is mainly concentrated in high-income countries, with another 12% in upper –middle income countries including, China, Russia and South Africa which contributed 7%, 3% and 2% of agents respectively. ii.While, Lower-Middle Income Countries (LMICs) including India, contributed 4% of the total share of anti-bacterial agents in clinical development by location of research facilities. India contributed only 1% to the global antibacterial R&D.

**iii.**As per the report, the number of antibacterial agents in the clinical pipeline, including antibiotics, increased from 80 (in 2021) to 97 (in 2023) worldwide.

- India now holds more nuclear weapons than Pakistan, which has recorded no increase in the number of warheads(170 in 2023 and 2024)said in 55th SIPRI Yearbook(2024).
- Nine nuclear-armed nations, including the United States of America (USA), Russia, France, China, India, Pakistan, the United Kingdom(UK), Israel and North Korea continued

modernising their nuclear arsenals and installed new nuclear-armed or nuclear-capable systems in 2023.

According to the International Campaign to Abolish Nuclear Weapons (ICAN) report, Global spending on nuclear weapons is estimated to have increased by 13%, to a record USD 91.4 billion during 2023. this is USD 10.7 billion higher than the global spending during 2022.
