- Dr. Archana Majumdar has been designated as a member of the commission for a three-year term.
- Vijaya Kishore Rahatkar served as the chairperson of the Maharashtra State Commission for Women from 2016 to 2021.
- She has led initiatives such as Sakshama (support for acid attack survivors), Prajwala (linking self-help groups to government schemes), and Suhita (a 24/7 helpline for women).
- Her accolades include the National Law Award and the Savitribai Phule Award from the National Literary Council.

   He also served as the Chief of the General Department of Politics under the Vietnam People's Army.
- He has been serving as a Permanent member of the Party Central Committee's Secretariat since May 2024.

- Paris (France) based the IBRO is a global federation of neuroscience organisations that
  promotes and supports neuroscience worldwide through training, education, collaborative
  research, advocacy, and outreach initiatives.

- He is recognized for his significant work in analytic number theory, especially his
  collaboration with Maksym Radziwill in solving the Kummer-Patterson Conjecture, which
  pertains to bias in cubic Gauss sums.
- Alexander Dunn has made notable strides in mathematics, particularly in analytic number theory. His work is characterized by its depth and innovation, contributing to solving long standing problems in the field.
- SASTRA Ramanujan Prize was established in 2005 by SASTRA University to honour young mathematicians who have made significant contributions to areas influenced by the works of legendary Indian mathematician Srinivasa Ramanujan.
- The recipient receives a cash award of USD 10,000.

- He will be presented with the Dada Saheb Phalke award at the 70th National Film Awards ceremony scheduled to be held on 8th October, 2024 at Vigyan Bhawan in New Delhi, Delhi.
- Mithun Chakraborty, also known as Mithun Da, was born on 16th June, 1950 in Kolkata, West Bengal (WB). During his long career in the film industry, he has acted in more than 350 films including, Bengali, Hindi, Odia, Bhojpuri, Tamil, Telugu, Kannada, among others.

- He holds a world record in the Limca Book of Records for releasing most films in a single year i.e. 19 films were released in 1989, a record which is still unbroken.
- In **2024**, He was honoured with the **Padma Bhushna**, India's 3rd highest civilian award in the category of Arts, presented by President Draupadi Murmu during a ceremony held at Rashtrapati Bhawan in New Delhi, Delhi.
- Dada Saheb Phalke award was instituted in 1969 by the Government of India (GoI) to commemorate the contribution of **Dhudiraj Govind Phalke** (Dada Saheb Phalke) to Indian cinema.

**Victor Ambros,** an American developmental biologist, and **Gary Bruce Ruvkun**, an American molecular biologist, were jointly awarded the **Nobel Prize in Physiology or Medicine 2024** by the Nobel Assembly at Karolinska Institutet, Stockholm, Sweden.

- They were honoured "for the discovery of microRNA and its role in posttranscriptional gene regulation".
- The award was announced by the Royal Swedish Academy of Sciences on 7th October 2024.
- Victor Ambros and Gary Ruvkun discovered microRNA, a new class of tiny RNA molecules that play a crucial role in gene regulation.
- MicroRNAs and their mode of gene regulation remained completely unknown until the discovery by Victor Ambros and Gary Ruvkun in 1993.
- The 2023 Nobel Prize in Physiology or Medicine was shared between Katalin Karikó and Drew Weissman "for their discoveries concerning nucleoside base modifications that enabled the development of effective mRNA vaccines against COVID-19".
- The Nobel Prize is an international award administered by the Nobel Foundation in Stockholm, Sweden, that recognises discoveries and achievements that benefit humanity.
- The award is based on the fortune of Alfred Nobel, a Swedish inventor and entrepreneur.

- They were awarded "for foundational discoveries and inventions that enable machine learning with artificial neural networks".
- Prize amount: 11 million Swedish kronor will be shared equally between the laureates.
- John J. Hopfield created a structure that can store and reconstruct information.

American biochemist **David Baker**, **Demis Hassabis**, the Chief Executive Officer (CEO) of DeepMind Technologies Limited, a subsidiary of Google, and American chemist **John Jumper** were jointly awarded the **Nobel Prize in Chemistry 2024** by the Royal Swedish Academy of Sciences in Stockholm, Sweden on 9th October 2024.

- The Nobel Prize is awarded to David Baker "for computational protein design" and to Demis Hassabis and John Jumper "for protein structure prediction".
- Prize amount, **11 million** Swedish kronor, with one half to David Baker and the other half jointly to Demis Hassabis and John Jumper.
- David Bake achieved the feat of building entirely new proteins.
- Demis Hassabis & John Jumper developed an Artificial Intelligence (AI) model to solve a 50year-old challenge: predicting the complex three-dimensional structures of proteins.
- A total of 116 Nobel Prizes in Chemistry have been awarded to 197 laureates between 1901 and 2024.
- Venkatraman "Venki" Ramakrishnan, an Indian-American biologist, won the Nobel Prize in Chemistry in 2009 "for studies of the structure and function of the ribosome". <u>Click here to</u> <u>read more.</u>

- The Royal Swedish Academy of Sciences in Stockholm, Sweden announced the award on 10th October 2024.
- Winners of the Nobel Prize will receive a medal, a personal diploma, and a cash award. Prize amount is **11 million** Swedish kronor.
- 'The Vegetarian', her first novel to be translated into English, won the 2016 Man Booker International Prize (renamed as International Booker Prize in 2019).
- A total of 117 Nobel Prizes in Literature have been awarded to 121 laureates between 1901 and 2024.
- Rabindranath Tagore was the first person from India and also the first Asian to win the Nobel Prize. He received the prize for Literature in 1913. <u>Click here to read more.</u>

- Prize amount is **11 million** Swedish kronor, to be shared equally between the laureates.
- The Medal of the Sveriges Riksbank Prize in Economic Sciences was designed by Swedish artist Gunvor Svensson-Lundqvist.
- In 1968, Sveriges Riksbank (Sweden's central bank) established the Sveriges Riksbank Prize in Economic Sciences in Memory of Alfred Nobel.
- The first prize in economic sciences was awarded to Ragnar Frisch of Norway and Jan Tinbergen of the Netherlands in 1969.
- Amartya Sen, the Indian economist and philosopher hailing from Santiniketan, West Bengal,
  won The Sveriges Riksbank Prize in Economic Sciences in Memory of Alfred Nobel in 1998 "for
  his contributions to welfare economics". He was affiliated with Trinity College, Cambridge, the

- She becomes the 2nd Brazilian, who will be honoured with this award, after Dom Paulo Evaristo Arns, former Sao Paulo Archbishop won the award in 1985.
- UNHCR has also named 4 other women as the winners of 2024 Regional winners of the UNHCR Nansen Refugee Award, in recognition of their exceptional work with refugees, internally displaced, and stateless people.
- The winners are **Maimouna Ba** from Africa, **Jin Davod** from Europe, **Nada Fadol** from Middle East and North Africa and **Deepti Gurung** from Asia-Pacific.
- The award was established in 1954 in the honour of Fridtjof Nansen, a Norwegian explorer, scientist, diplomat and Nobel Laureate who became the 1st High Commissioner for Refugees (1920-1930) for the League of Nations (predecessor of UN).
- Global laureate of the award receives a commemorative medal and a monetary prize of USD

- Neetu Lawrence David became the 2nd woman from India and 10th Indian to be inducted into the ICC Hall of Fame following the induction of **Diana Fram Edulji** in 2023.

- The study was conducted by the Madras Diabetes Research Foundation(MDRF) with the collaboration of Indian Council of Medical Research (ICMR) and the Department of Health Research, under the Ministry of Health and Family Welfare (MoH&FW).
- The findings of the study will help to assess the health burden due to Diabetes, prediabetes and metabolic **Non-Communicable Diseases** (NCDs).
- The total participants screened for diabetes and other metabolic disorders in all the phases
  of the study were 1,21,077, which makes it one of the largest epidemiological studies on
  diabetes on a global scale.
- As per the survey, the overall prevalence of hypertension, generalized obesity and abdominal obesity in Jammu came out to be 27.1 %, 41.7 % and 62.7 % respectively.
- According to the ICMR-INDIAB study, 10.8% of the population in Jammu region is affected
  by prediabetes, showing that there is an urgent need for action against the growing burden
  of NCDs in the region.
