On 22nd October 2024, Union Minister **Jyotiraditya Madhavrao Scindia**, Ministry of Communications **(MoC)** and Ministry of Development of North Eastern Region **(MDoNER)** launched **"International Incoming Spoofed Calls Prevention System"** at the Bharat Sanchar Nigam Limited (BSNL) Bhawan in New Delhi, Delhi.

- The system is designed with the objective to reduce the number of fraudulent calls that display a +91(India) prefix but originate from abroad.
- This system is developed by the DoT under MoC which has collaborated with Telecom Service Providers (**TSPs**) to identify and block such incoming international spoofed calls from reaching the Indian telecom subscribers.
- These spoofed calls have been used by cyber criminals to commit various cybercrimes such as financial scams, impersonating government officials, among others.

 He also launched the 21st Livestock Census which will be conducted till February 2025 at a cost of Rs 200 crore.

- The "Animal Health Security Strengthening in India for Pandemic Preparedness and Response" initiative will play a pivotal role in alleviating the risk related to zoonotic diseases that can spread from animals to humans.
- The main objective of the project is to enhance the country's capacity to prevent, detect, and respond to animal health threats.
- It will be implemented in collaboration with Asian Development Bank (ADB), Food and Agriculture Organisation (FAO) and the World Bank Group (WBG).
- The G20 Pandemic Fund was established under Indonesia's G20 Presidency in 2022.
- 21st Livestock Census will provide the updated data on the livestock population, which will
 help the government to address key issues like: disease control, breed improvement, and

Union Minister Rajiv Ranjan Singh aka Lalan Singh, Ministry of Panchayati Raj (MoPR) along with Dr. Jitendra Singh, Minister of State (Independent Charge), Ministry of Science and Technology (MoS&T) and Minister of State (MoS) Satya Pal Singh Baghel, MoPR launched the 'Gram Panchayat-Level Weather Forecasting' initiative in Vigyan Bhawan, New Delhi, Delhi to provide daily weather updates to Gram Panchayats on temperature, rainfall, wind speed, and cloud cover.

- This is the first time that localized weather forecasts will be available at the Gram Panchayat level. It is developed in collaboration between MoPR and the India Meteorological Department (IMD), Ministry of Earth Sciences (MoES).
- This initiative provides 5 days daily weather forecasting and provision to check hourly weather forecasts.
- Weather forecasts will be accessible through digital platforms like Meri Panchayat application(app), eGramSwaraj, Mausamgram, and Gram Manchitra, enhancing local governance and transparency.
- Mausamgram is an initiative by the IMD designed to deliver location-specific weather forecasts at the Gram Panchayat level, aiming 'HAR HAR MAUSAM HAR GHAR MAUSAM' (weather information for every household anytime).

- As per the provisions of Sub Rule 6 of Rule 44 of central civil services (CCS)(Pension) Rules 2021 [erstwhile Rule 49(2-A) of CCS(Pension) Rules 1972], after completion of eighty years of age or above by a retired Government servant, in addition to a pension or a compassionate allowance admissible under the rules.
- A compassionate pension is a special allowance that the government may grant to an employee or their family in certain circumstances.

- The CRS mobile app is a part of Prime Minister (**PM**) Narendra Modi's vision of digital India. It is a significant initiative to integrate technology with governance.
- The app will allow citizens to **register the birth and death** at any time, from any place, and in their state's official language.

- Alongside this center, India AI, Meta in collaboration with the All India Council for Technical Education (AICTE) have launched the "YuvAi Initiative for Skilling and Capacity Building" to empower India's youth in AI.
- With Meta Platforms, Inc.'s support, the Generative AI Center of Excellence (GenAI CoE) at IIT Jodhpur will serve as a hub for responsible and ethical AI research and development in India.
- Meta, in collaboration with IndiaAI, MeitY, and AICTE, has introduced the YuvAi initiative, which aims to upskill 100,000 young Indians aged 18-30 in AI.

- During the event, Indian Railways and MoWCD has also announced expansion of Child Help Desks (CHDs) at major railway stations, aimed at strengthening the support network available to children in need.
- This comprehensive SOP lays out a robust framework for protecting children who come into contact with Indian Railways.
- Anil Malik, Secretary of MoWCD highlighted various measures initiated by Indian Railways to
 enhance the safety and security of juveniles like: installing Closed Circuit Television (CCTV)
 and face recognition technology at upgraded railway stations.
- Over the last 5 years, RPF has rescued 57,564 children from human trafficking, out of them 18,172 were girls.
- RPF has introduced various focused initiatives under the "Operation Nanhe Farishte" to
 ensure safety of children throughout the railway network.
- Operation Meri Saheli was launched on 29th October, 2020 which aims to ensure the safety
 of single ladies travelling in trains.
- The Government of India (GoI) had established a dedicated fund called "Nirbhaya Fund" in 2013, for implementation of initiatives aimed at improving the safety and security for women in the country. <u>Click here to read more.</u>

As per the data by the Ministry of Rural Development **(MoRD)**, Rural employment under Mahatma Gandhi National Rural Employment Guarantee Act 2005 **(MGNREGA)** has increased in the last 10 years. From the Financial Year 2006-07 (FY07) to FY14, a total of **1,660 crore person-days** were

generated. In contrast, between FY15 and FY25, the total person-days increased significantly to **2,923 crores**.

- This represents an increase of approximately 76.1% in person-days generated over the two
 periods.
- The MoRD also informed that Adhaar seeding has been done for around 13 crore active workers, which is 99.3% of total active workers. It enabled to minimise the rejection of transactions due to the frequent changing of accounts.
- The budget allocation for MGNREGA has also increased to 86,000 crores during FY 2024-25 budget allocation from Rs 33,000 crore during FY 2013-14.

- This certification highlights the commitment to sustainable infrastructure and eco-friendly

- This initiative aligns with the government's vision to develop Kangra as a model for ecotourism, reinforcing its reputation as the "Tourism Capital" of HP.
- The zoo's development is progressing in phases. The first phase, spanning 25 hectares, has a projected cost of Rs 230 crore and is set for completion by the third quarter of 2025.
- The entire park, with a budget of Rs 619 crore, will boost tourism in Kangra and its neighbouring areas, creating a thriving, eco-friendly attraction.

- The reformed council will focus on driving reforms to enhance apprenticeship training and increase industry participation in on-the-job training.

- Union Minister of State (Independent Charge, IC), Jayant Chaudhary, MSDE will chair the
 council, with Rajya Sabha member Vikramjit Singh Sahney will be the vice-chairman of the
 council.
- The CAC, a statutory body under the Apprenticeship Act, 1961, advises the Central Government on implementing the Apprenticeship Act across India. It is reconstituted every three years.
- The CAC has suggested raising the apprentice participation cap in establishments from 10% to 15% of the total workforce, with at least 5% allocated specifically for new apprentices.

- According to the revised guidelines, daughters who are unmarried, widowed, or divorced or over the age of 25 years may also receive a family pension only if their siblings are either above the age of 25 or financially independent.
- Female government employees or pensioners involved in ongoing divorce proceedings, or

 family pension benefits for their children in the event of their death.
