- MCs' revenue receipts rose by **20.1%** YoY (Year-on-Year) to Rs 1.7 trillion in FY24, up from Rs 1.42 trillion in FY23 and Rs 1.37 trillion in FY22.
- MCs' revenue expenditure grew by **13.9%** to **Rs 1.49 trillion** in FY24 from Rs 1.31 trillion in FY23 and Rs 1.23 trillion in FY22.
- The consolidated budget of MCs shows a surplus, but it decreased from Rs 4,914 crore in FY19-20 to Rs 1,034 crore in FY20-21. The FY23-24 budgeted surplus is **Rs 20,819 crore**.
- Regular formation and timely implementation of State Finance Commissions (SFCs)
 recommendations are crucial for proper state funding.
